RE: **Urgent Warning that AL FRENZEL of Hawaii -- an Anti-Statehood Secessionist, Closet Democrat, and Political Progressive -- Has Wormed His Way Into the Trump Administration, the Trump Campaign, and the Republican Party - BE WARNED**

Dear President Trump:

As president of the pro-Trump Hawaii Republican Assembly (HIRA) and chairman of the HIRA Action superpac, I am urgently writing you today to share my strong objection on behalf of thousands of conservatives and Republicans in Hawaii that **Al Frenzel**, a liberal, anti-statehood separatist who wants the U.S. military out of Hawaii, has been leading your Hawaii Trump campaign effort, holds a federal job with the USDA by way of your presidential appointment, and holds the #2 position at the Hawaii Republican Party, with the full knowledge of the entire leadership of the Hawaii GOP who share Frenzel's far-left, separatist bent. His supporters include liberals and anti-statehood activists within the party like state chair Shirlene Ostrov, sovereignty activist Andria Tupola, and more.

I understand that there can be breakdowns in the vetting process used by political organizations and campaigns. But I find it hard to believe that Mr. Frenzel has so many people in the Trump and RNC universe fooled for so long. While I don't hold you responsible, it's a real insult to

conservatives and Republicans in the Aloha State that a closet Democrat was put in charge of the 2016 Trump Hawaii campaign and that he (along with any of his many liberal associates at the Democrat-controlled Hawaii GOP, such as RINO Shirlene Ostrov who handpicked Frenzel to be her #2) are now under consideration for the 2020 effort. You can ask any Republican or any reporter in Hawaii and easily confirm that the Hawaii GOP under Frenzel and Ostrov has been refusing to take the fight to Democrats for years; allowing Democrats to sleep soundly at night. This is NOT fake news. This is the sad reality of surrender by Frenzel and his cohorts.

Allow me to conclusively explain and illustrate why Mr. Al Frenzel's continued association with the Trump campaign, the Trump administration and the Republican Party will harm the Trump re-election effort in Hawaii as well as harm the prospect of electing any Republicans here in Hawaii. Not only will Frenzel, Ostrov and their like-minded RINO delegates harm your Trump-Pence ticket, but they will do lasting damage beyond the 2020 convention in Charlotte.

Permit me to front-load this **'executive summary'** before explaining the details:

1. Frenzel Actually Wants the State of Hawaii to Secede from the United States in order to become an independent, third world country
2. Frenzel is a Closet Democrat Who Consistently Refuses to Allow the Hawaii GOP to Fight for the Trump Agenda Here in Hawaii
3. Frenzel Wants the U.S. Army to Be Pulled out of Hawaii Completely to Give the Lands and Infrastructure of Army bases to Ethnic Part-Hawaiians Exclusively
4. Frenzel's Official and Insanely Bad Predictions at the U.S. Army War College Concerning America's Enemies Will Prove Disastrous for Hawaii and the United States
5. Frenzel Abuses the Trump Hawaii Campaign Database for His Personal, Liberal Agenda

Now, to prove that these are not unwarranted allegations, here are the details for each of these very important reasons for you to immediately distance the Trump campaign, the Trump administration, and the Republican Party from progressive secessionist Al Frenzel. I cannot believe for a moment that somebody with these beliefs would be associated with your administration, your campaign or our party.

### **ISSUE #1 - Frenzel Wants the State of Hawaii to Secede from the United States**

Just last month, Hawaii celebrated its 60th anniversary as a state. Due to Frenzel's opposition to our even being a state, he used his position as head of the Trump campaign and as second

in command at the Hawaii GOP to ensure that the state party and the Trump Hawaii re-election effort did absolutely nothing at all to align the president or our party with this important milestone. Why? Here's why.

Al Frenzel -- a failed Libertarian Party candidate who has wormed his way into top Trump and GOP posts -- **openly supports seceding from the United States, getting the U.S. military to leave Hawaii, and turning the tiny islands of Hawaii (including Honolulu, the 11st largest city in the USA) into a third world independent country.**

To improve his chances of successfully infiltrating Republican circles, Frenzel wisely took his incendiary libertarian website offline. But as you know, in the digital age, nothing really disappears. Scroll down and you'll see the green, yellow and red anti-USA "sovereignty flag" (shown below) which Frenzel posts on his site as a direct appeal to other statehood haters so that they'll know he's one of them. If you click on the reggae-colored flag and you'll be taken to his declaration of support for restoring Hawaii as a sovereign independent nation; strategically located under the picture of former Hawaii Queen Lili'uokalani on the throne, in an obvious indication of agreement with other anti-statehood activists whom secessionist Frenzel has long romanced: ***"I support Hawaii's dream of achieving international recognition and independence as a sovereign country. It is a righteous goal -- sovereignty, self-determination and independence. The Hawaiian sovereignty movement should be applauded and celebrated."*** - Al Frenzel

Let me be absolutely clear. Frenzel is a stooge for the radical anti-statehood ‘sovereignty’ mob which wants to help secessionists push the U.S. completely out of Hawaii. By openly supporting and actively working toward the secession of Hawaii from the United State of America, retired colonel Al Frenzel is an embarrassment to the U.S. Armed Forces and arguably a traitor to our state and country.

## **ISSUE #2 - Frenzel is a Closet Democrat Who Consistently Refuses to Fight for Trump's Agenda Here in Hawaii**

First of all, Frenzel is an unabashed liberal masquerading as a Republican and masquerading inside GOP circles as a supporter of President Trump's agenda. The cold reality is that Frenzel doesn't even want to attempt to sell that agenda here in Hawaii in order to help Trump win. Only four months after the 2016 Election, here's how Frenzel himself expresses his disdain for Trump's agenda in an e-mail to the State Committee of the Hawaii GOP . . .

***"Hawaii's voters are two standard deviations left of center; the sooner we accept and adjust to this the more successful we will be – they WILL NOT bend towards the right for us – the trade winds are constantly blowing them left."*** - Frenzel on Tuesday, March 7, 2017 @ 12:03 p.m.

Three months after that, Frenzel opined about his insistence on pandering to liberals while attacking conservatives (whom Frenzel dismissively regards as "alt-right") in his e-mail to 2018 Republican gubernatorial candidate John Carroll:

***"WE CANNOT HAVE AN ALT-RIGHT PARTY AND EXPECT TO WIN ANY RACES – we are Hawaii – two standard deviations left of the mean. We either adjust OUR mean or we perish. Hawaii of 2017 is not the same as it was twenty or thirty years ago – we have shifted very far left and every generation will shift further left. There is nothing the alt-right can do to package ALL Republican values in a way that will be palatable, let alone attract enough voters for us to be a viable party in Hawaii."*** - Frenzel on Tuesday, June 20, 2017 @ 5:00 p.m.

Then, a mere four months ago, Frenzel revealed that he's anything BUT a Republican when explicitly aligning himself ("**Way to go Garrett; we need to meet up some time.**") with Garrett Takahashi, a longtime, far-left member of the left-leaning Hawaii GOP leadership, who wrote the following in an e-mail to the State Committee of the Hawaii GOP:

***"We should be even more like Democrats. They win. Why fight that? People want Democrats. People want tax and spend and abortion on demand and rail and to fund agencies like OHA. We Republicans are not here to change Hawaii. We are here to give people what they want. If voters want more of the same, let's give them more of the same. Enough already. It's not pandering. It's WINNING."*** - E-mail to Frenzel and Hawaii GOP State Committee on 5/20/19 @ 6:21 p.m.

Frenzel's casual embrace of liberalism on issue after issue is just downright scary. If the Trump campaign was comprised of those with half the weak-stomached quitter mindset as Al Frenzel, then President Hillary Clinton would be running for re-election today. To wit, here's a disturbing excerpt from what has come to be known among conservatives inside the Hawaii GOP as

Frenzel's "surrender memo", in which Frenzel announced that Hawaii was a lost cause because our state is too far gone politically in the progressive direction:

***"70%+ of the population of Hawaii is left of left, deeply into socialism and very near neo-communism. There aren't enough door hangers in the world to stop Hawaii's ever-deteriorating ideological character – teachers and the media produce more socialists per day in Hawaii than we can comprehend. Hawaii has changed dramatically over the past 30 years."*** - Frenzel on August 11, 2017 @ 7:39 p.m.

As you can plainly see, while waving his proverbial white flag, Hawaii GOP state chair Ostrov's handpicked vice-chair Al Frenzel repeatedly advises state and local Republicans against being too Republican; instead urging that Republican candidates be even MORE like Democrats. What kind of head of the Trump campaign in Hawaii dismissively regards Donald Trump's platform and values and principles as being dead-on-arrival in Hawaii and wants Republicans (including our nation's president) to be more like Democrats to fit in? What kind of Trump appointee and vice-chair for a state party believes that Hawaii cannot be saved from failed Democrat policies? The same Al Frenzel who allows Democrats and Antifa and progressive groups in Hawaii to routinely attack Trump and Republicans without consequence or rebuttal.

I could go on and on about Frenzel's reluctance to utilize the machinery of the Hawaii Republican Party (of which he is 2nd in command) to influence voters during the 24 months between elections or the 24 months before that. But conservative-hating Frenzel is a disaster as a Trump Hawaii leader and as a GOP leader. He is harming both efforts from inside.

Five minutes of research at your end will reveal that Frenzel -- *the current Vice Chair of Coordinated Campaigns for the Hawaii GOP, handpicked by RINO state chair Shirlene Ostrov* -- has used his position to ensure that the state Republican Party has undertaken zero Voter ID, zero Voter Registration, and zero messaging during his entire time as an officer of the state party. With the assistance of fellow closet Democrat (state chair) Ostrov and others, Frenzel is ensuring that Hawaii ballot Republicans generally and Donald Trump specifically will fail dismally in 2020.





*In a 01 June 2014 mass e-mail announcing his candidacy as a Libertarian Party candidate, Frenzel explains, "After much thought and internal debate, I am planning to run as a **Libertarian candidate in the 2014 election for State House District 44. I am an issues guy and more aligned philosophically with the Libertarian Party - I think most people are Libertarian; they just don't realize it.** <http://www.lp.org/platform>"*

Two years after announcing his values (above) in a campaign he lost badly, Frenzel had wormed his way into your campaign. Three years after this announcement, he wormed his way into your administration. Four years after, he became 2nd in command at the Hawaii Republican Party and has used all his influence in concert with other RINO's to keep the Hawaii GOP and the Hawaii Trump campaign from promoting your agenda, your successes, your goals. Democrats sleep very well at night, thanks to Frenzel, Ostrov and their pals.

### **ISSUE #3 - Frenzel Wants the U.S. Army to Be Pulled out of Hawaii Completely to Give the Lands and Infrastructure to Ethnic Part-Hawaiians Exclusively**

Not only is "Separatist Al" Frenzel openly aligned with radical secessionists who oppose Hawaii remaining the 50th State so it can return to being a third world monarchy nation, he simultaneously advocates for **massively cutting military spending, nationally and here in Hawaii**. He wants something unthinkable for a retired military officer — **he wants the U.S. Army completely GONE from Hawaii.**

On his 2014 campaign website (*which seems to have escaped the notice of those performing your campaign's and your administration's vetting*), Frenzel features a videotaped interview with noted America-hater Mililani Trask. Not surprisingly, Frenzel writes on his website that, "**Al's topic of Army Downsizing was greeted with enthusiastic support by Mililani.**" No kidding. Like Frenzel, she hates statehood and wants the U.S. Military GONE.

On 16 November 2014, the Honolulu Star-Advertiser published Frenzel's column advocating the virtual elimination of the Army from Hawaii's main island of Oahu. Frenzel's final plea -- "**Please Hawaii, let the Army go; cut the umbilical cord that is sucking the life out of both the host and its guest.**" Yes, that's precisely how Frenzel and his anti-statehood comrades feel about the military presence in Hawaii.

Online videos such as this interview ([https://www.youtube.com/watch?v=0o4Tg\\_k5vl4](https://www.youtube.com/watch?v=0o4Tg_k5vl4)) demonstrate that Frenzel has dangerous views which put him at great odds with mainstream

Republicans. Not disclosed in this interview is that retired colonel Frenzel was the Libertarian candidate for state house district 44 (Wai'anae, Makaha, Ma'ili, Makua).

As Frenzel explains in this interview with Civil Beat (<https://www.civilbeat.org/2014/07/candidate-qa-house-district-44-al-frenzel/>), he wants the U.S. Army withdrawn 100% from Hawaii. ***"I strongly believe the state of Hawaii should embrace these cuts and call for the return of Schofield Barracks, Wheeler Army Airfield, Dillingham, Makua, and Kolekole pass access to the state of Hawaii."*** Frenzel wants to transfer military (especially Army) lands exclusively to those of part-Hawaiian descent. ***"Schofield Barracks' and Wheeler AAF's numerous family housing units and unaccompanied barracks facilities house 37,799 soldiers and their family members. These newly built and newly renovated facilities would make a huge dent in DHHL's (the State Department of Hawaiian Homelands) waiting list as well as providing accommodations for the growing homeless population on Oahu. These homes could immediately provide truly affordable housing to deserving beneficiaries that have been on DHHL's waiting list for more than a lifetime in many cases."*** So, Frenzel would make Hawaii and America less safe in order to pander to his anti-USA buddies in the anti-Statehood sovereignty movement -- equal citizens who want FREE land and FREE housing from the government at everyone else's expense.

Driving the point home that he wants the U.S. Army out of Hawaii, Frenzel adds what he is personally doing to get the Army out of Hawaii: ***"I have recently established the Oahu Council for Army Downsizing and have been inviting like-minded organizations throughout Oahu to be represented on the council to join in a concerted effort to influence Oahu's citizens and their elected representatives to embrace the DoD's proposed downsizing. The state of Hawaii should not fight this issue as the other 18 states will desperately do; but instead, should willingly agree to the cuts and ask the Congress and President Obama for a financial transition assistance package to ease the short-term impact that will affect some businesses and jobs on Oahu. This is a once-in-a-century opportunity. If military forces on Oahu are not cut during this round, then nothing will change militarily on Oahu —there will never be another round of cuts like this in any of our lifetimes. The valuable assets at Schofield, Wheeler, Makua and Dillingham will never be returned to the people of Hawaii."*** Frenzel's video of his presentation to promote getting the U.S. Army out of Hawaii can be seen here:

In Frenzel's press release, he makes clear that he wants the Army out so that he can repurpose the infrastructure of military housing and other buildings on these bases for the immediate benefit of a single ethnic group of Americans in Hawaii: ***"These homes could immediately provide truly affordable housing to deserving beneficiaries that have been on DHHL's (the State Department of Hawaiian Homelands) waiting list for more than a lifetime in many cases."*** Again, Frenzel selects a single ethnic group to benefit from Army cuts.

I seriously doubt that the Trump campaign, the Trump administration or anybody at the Republican Party ever reviewed Frenzel's wacky policy leanings.

Frenzel even tells the Honolulu Star-Advertiser (<http://elections.staradvertiser.com/allen-al-frenzel/>) that his "one big idea" for Hawaii is to get rid of the U.S. Army and give all the lands from its installations to the state government: ***"Recently, the Department of Defense announced that Hawaii is one of 19 states to potentially lose stationed soldiers as part of the Army's mandated downsizing from 550,000 to 420,000. I STRONGLY support the proposed cuts for Hawaii (19,800 on Oahu) and immediate return of Schofield, Wheeler, and Makua to the state of Hawaii."*** Again, Frenzel repeats his demand that we all sacrifice national security so he can divert resources being used for everyone's benefit to the benefit of just a few based on skin color.

What a huge coup it would be for Hawaiian independence activists like Frenzel and his radical buddies to defeat the Army -- to literally have the U.S. Army in Hawaii **surrender entire military bases to the sovereignty activists**, complete with fully developed towns ready for the exclusive use of ethnic part-Hawaiians, most of whom are 100% integrated into American life but are being used by Frenzel and his radical buddies as pawns to grab land and power. Sort of like how the ISIL army was taking over towns in Iraq and capturing tanks, guns, and ammunition left behind by the departing U.S. military. Unthinkable in America!!

On 21 July 2014, Frenzel appeared on a radio show to advocate getting the U.S. Army out of Hawaii. At the 7:20 mark, Frenzel again makes it clear that he wants the Army out so that a single ethnic group in Hawaii can reap the benefits: ***"Free up those two facilities (Schofield + Wheeler) near Wahiawa that currently house 39,000 family members . . . Think how many people off the DHHL (State Department of Hawaiian Homelands) waiting list."***

Frenzel even pushed for support of his anti-Army campaign's petition on the progressive website Change.org to kick the U.S. Army out of Hawaii:

On 14 October 2014, Frenzel held a special meeting to coach anti-statehood, anti-USA activists on how to successfully advocate for downsizing the U.S. Army ***"in illegally occupied sovereign Hawaiian kingdom land"*** without appearing ***"hostile"*** toward the federal government.

FRENZEL: ***"This is an opportunity for all of Hawaii and your separate agendas."*** 2:02:20

FRENZEL (regarding Schofield and Wheeler): ***"Basically two cities, one big city and one small city, ready to be occupied."*** 00:18:00

Mr. Frenzel was filmed at this event and the footage posted by a group calling itself ***"the Hawaiian Kingdom Government presently operating within the occupied State of the Hawaiian Islands."*** <http://hawaiiankingdom.org>

In a September 2014 televised appearance billed as "The Sovereignty Conversation" alongside noted anti-statehood sovereignty activists Leon Siu, Hayden Burgess, and Kioni Dudley, Al Frenzel appeared as a guest with his anti-statehood compatriots to sell viewers on pushing the U.S. Army out of Hawaii. According to the shows producers, "Special guest Col. AL Frenzel, US Army (Ret) then speaks on the significant military downsizing that is possible to accomplish in the next several months and the **advantages for the people of the state and for Hawaiian sovereignty movement** that could come from it. At the 31:03 mark . . .

FRENZEL: ***"This is a once in a century opportunity. If the forces aren't cut . . . we will never have this opportunity again."***

LEON SIU (secessionist): ***"Unless the Hawaiian Kingdom comes back."***

FRENZEL: ***"I agree. That's always given. But, if not, and in the meantime, once the Army cuts, and if Senator Inouye gets in the way of this . . . the Army wont go below 420,000 in our lifetimes."***

At the 35:48 mark . . .

FRENZEL: ***"The community should understand that the services don't decide where they go. Congressmen and senators decide."***

LEON SIU (secessionist): ***"And independent nations."*** Causing Frenzel to smile broadly.

There you have it. **Frenzel wants the vast majority of the U.S. Military in Hawaii to be REMOVED from Hawaii.** Combined with his stated desire to kick the United States COMPLETELY out of Hawaii, it's clear that **Frenzel is a dangerous influence who has infiltrated the Trump campaign, the Trump administration and the Republican Party.** Frenzel knows that the existing Hawaiian Homelands program already controls 200,000 acres in Hawaii for the exclusive benefit of part-Hawaiians; most of which is still (after the program's 100 years in action) unutilized by Democrats and very much available. But anti-statehood Frenzel would like to kick out the Army from multiple bases and generously hand over the land and buildings and infrastructure to members of one ethnic group exclusively, while pushing for his vision of Hawaii's secession from the United States.

#### **ISSUE #4 - Frenzel's Official and Insanely Bad Predictions at the U.S. Army War College Concerning America's Enemies Will Prove Disastrous for Hawaii and the United States**

One of the ways that Frenzel appears to have infiltrated the Republican Party and the Trump campaign and Trump administration is by constantly name-dropping that he had some connection to the U.S. War College. But just read a few cringe-inducing highlights of his bogus predictions in his very own report:

ON NORTH KOREA: ***"North Korea is a legitimate conventional threat that must be closely monitored in the near term; however, by 2015 the communist regime will collapse from its own weight."*** Hmm, it's 2019 and North Korea is still going strong.

ON RUSSIA: ***"Russia is no longer a conventional threat and will not become one by 2015. It continues to deteriorate as its failed attempt towards capitalism breaks down and propels the country back to a pre-industrial state."*** Right, tell that to the people of the Ukraine and the Crimean peninsula and Georgia.

ON CHINA: ***"The claim that China will emerge as America's next military peer competitor (and accordingly that we should begin "containing" Beijing now) is monumentally premature, and its very advancement risks becoming a self-fulfilling prophecy. It assumes on China's part, three or four decades hence, a degree of hostility and measure of imperial ambition that is simply not predictable."*** Somebody tell Frenzel that China turned out the exact opposite way he predicted and has already claimed territory.

ON THE U.S. HAVING 'NO RIVALS': ***"Composed primarily of conventional forces, with nuclear deterrent capability, America's military is obsolete for post cold war realities. The***

***United States is the world's only superpower. A credible peer competitor does not exist to challenge the U.S. nor is one expected through the year 2015.*** Again, somebody tell Frenzel about China and Russia - turning out the exact opposite way he predicted. Even Mitt Romney understood in 2012 what Obama and Frenzel did not -- Russia didn't go away.

Frenzel's predictions remind me of how Al Gore predicted the elimination of ice caps and the extinction of polar bears. This guy is a complete IDIOT. And now he wants to unilaterally disarm Hawaii of its Army forces and make us more vulnerable to regional and global threats. How did this guy become head of Trump Hawaii? No wonder Frenzel led the Trump campaign in Hawaii to a 2-to-1 loss to Hillary Clinton under his poor leadership.

According to Frenzel during his appearance on an anti-American public access TV show (<https://www.youtube.com/watch?v=Hix44L1-fSk>), his U.S. War College report excerpted above is the very report which led him to believe that the Army could be 'safely' and completely yanked from Hawaii, rendering us defenseless. In this same video, Frenzel asserts that he can't find anything negative about the idea of pulling the Army completely out of Hawaii, closing the bases, and handing them over to the needy.

### **ISSUE #5 - Frenzel Abuses the Trump Hawaii Campaign Database for His Personal, Liberal Agenda**

I doubt that the Trump campaign has ever granted Frenzel the authority to utilize the official Trump campaign database for Hawaii to pursue his liberal agenda, such as attempting to influence the outcome of internal party elections in favor of his liberal buddies. But Frenzel has been abusing the Trump campaign database nonetheless. Just one recent example took place in March 2019 when Frenzel wrote several e-mails to "Aloha Trump Supporter" and openly backed the liberal candidate for Honolulu's county party chairman using the imprimatur of the Trump campaign when writing, *"For the sake of our local Party and the upcoming 2020 election for President Trump, please attend the Honolulu County Convention and vote Henry Vincent in as our County Chairman."*

Frenzel wanted fellow anti-statehood liberal Henry Vincent to beat hardworking conservative Trump supporter Brett Kulbis to lead Hawaii's largest county party committee because Frenzel despises patriotic incumbent county chair and Navy veteran Kulbis who has been championing conservative reforms in Hawaii. Was this (*or any other misuse of the Trump mailing list*) ever run up the flagpole to Trump Tower by Frenzel for permission? I really doubt it.

While Frenzel refuses to fight for your agenda here in Hawaii, he routinely abuses your trust to pursue his personal, liberal agenda utilizing your campaign's valuable contact lists.

### **ISSUE #6 - Frenzel Just Joined With Democrats in Donating to a Democrat Candidate**

In March 2019, Frenzel joined with various Democrat-aligned labor unions and other well known backers of the Democratic political machine in financially supporting Democrat city council Trevor Ozawa with a donation earlier this year. At the time, Frenzel held the position of being the Hawaii GOP's district chairman for state house district 44. Loyalty to the GOP is not Frenzel's strong suit by any measure.

### **ISSUE #7 - Frenzel is currently under investigation by the U.S. Attorney, the F.B.I., the Hawaii Attorney General, the Federal Election Commission, the State Campaign Spending Commission, and the federal Office of Special Counsel**

It is my firm understanding that Mr. Frenzel is intimately caught up in the criminal investigation of the Hawaii Republican Party as an accomplice to Shirlene Ostrov, Gene Ward, Miriam Hellreich and others in the matter of conspiracy, wire fraud, money laundering, obstruction, defrauding the U.S. and false reporting to the FEC and to the State of Hawaii. But I'm sending it to you again now out of concern for how much worse that Frenzel and his associates have made things here in Hawaii.
